



## UPDATE FROM THE CONGREGATIONAL COUNCIL ON COVID-19

*June 18, 2020*

The last few months have brought a lot of uncertainty. We went from living our daily routines to living in a worldwide pandemic. Life, as many of us knew it, came to an abrupt halt to help “flatten the curve.” Most days have been met with some level of uncertainty (frustration, worry, concern) while the information on COVID-19 remains overwhelming and ever-changing.

When St. James temporarily closed its doors on March 15 due to the pandemic, we quickly pivoted to meet members in some capacity during these trying times. We started weekly, pre-recorded services as well as daily devotionals, available online and distributed via email/social media. While this does not replace in-person worship, we have received positive feedback from these efforts of staying connected.

Reopening St. James has been a monthly topic for the Congregational Council (Council). We recently sent out a survey to get a pulse on your thoughts, comments and concerns. Thank you to everyone who has already filled out the survey. In our June 18<sup>th</sup> Council meeting we spent most of our time discussing the results and how to apply it to resume in-person services.

### **We asked. You answered. And the survey\* says...**

More than half who responded feel comfortable returning to in-person worship within the next 3-6 months. An overwhelming majority stated they would like to continue the offerings of daily devotionals and live/pre-recorded services even when we resume in-person services. We will plan to continue these efforts after reopening.

#### Comfort returning to in-person worship

60% of members **would be comfortable** returning to worship in-person within 3 to 6 months.  
30% of members **will not be comfortable** returning to worship in-person until a vaccine is available.

*“I’m susceptible to severe illness from the virus due to age, so I need to be very cautious. Your wonderful pre-recorded online worship services have been my lifeline and I am most grateful. When in-person worship resumes, please find a way to continue providing online worship for those of us who cannot attend in person. Thank you!” – Anonymous comment from a member*

#### When we resume worship services in our facility, what will you most likely attend?

36% of members said they would be most likely to **attend in-person** (in our facility) services.  
28% of respondents said they would be most likely to **attend online** (pre-recorded) service.

*“I hope we can resume a combination of in person and online worship very soon. It’s helpful to us to get back to some semblance of normal, whatever that will be! What our church is doing to help us continue to worship and the daily devotions have been inspiring and uplifting. Thanks for doing this for us!” – Anonymous comment from a member*

#### What online programming would you like to see offered in the coming months?

48% of members said they would like an online option for Bible study, mediation, and/or evening prayer.

We will continue to look for ways for members to engage with our pastors and other members online during this time. Possible opportunities include mid-week informal connections via Zoom. Stay tuned!

## What will in-person services look like?

Services will not look like they did pre-pandemic. Masks, social distancing, limited attendance, no congregational singing, and shorter services are all items under consideration for the safety of members. Please know we are approaching the reopening cautiously and thoughtfully. The Council is also taking guidance from the Centers for Disease Control and Prevention (CDC), Evangelical Lutheran Church in America (ELCA), and an ecumenical document entitled “Resuming Care-Filled Worship and Sacramental Life during a Pandemic.” Additionally, with so many businesses and churches reopening we can learn from their successes and shortcomings.

## Next Steps

The survey results have been helpful in initial planning. There is a lot of information to sort through and make decisions specific for our congregation. After careful consideration of all the factors, and with your safety at the center, the St. James Council passed a motion to target a reopening for mid-September 2020. As reopening will require many decisions and many people, we are forming a “Reopening Task Force. Over the next few months the Council, along with the Reopening Task Force, will focus on creating guidelines and a plan to reopen St. James for worship. While our target to reopen is mid-September 2020, please know this date could change at any time given Wisconsin COVID-19 results and direction from local/national health organizations. The Council will continue to provide updates for the congregation as they become available.

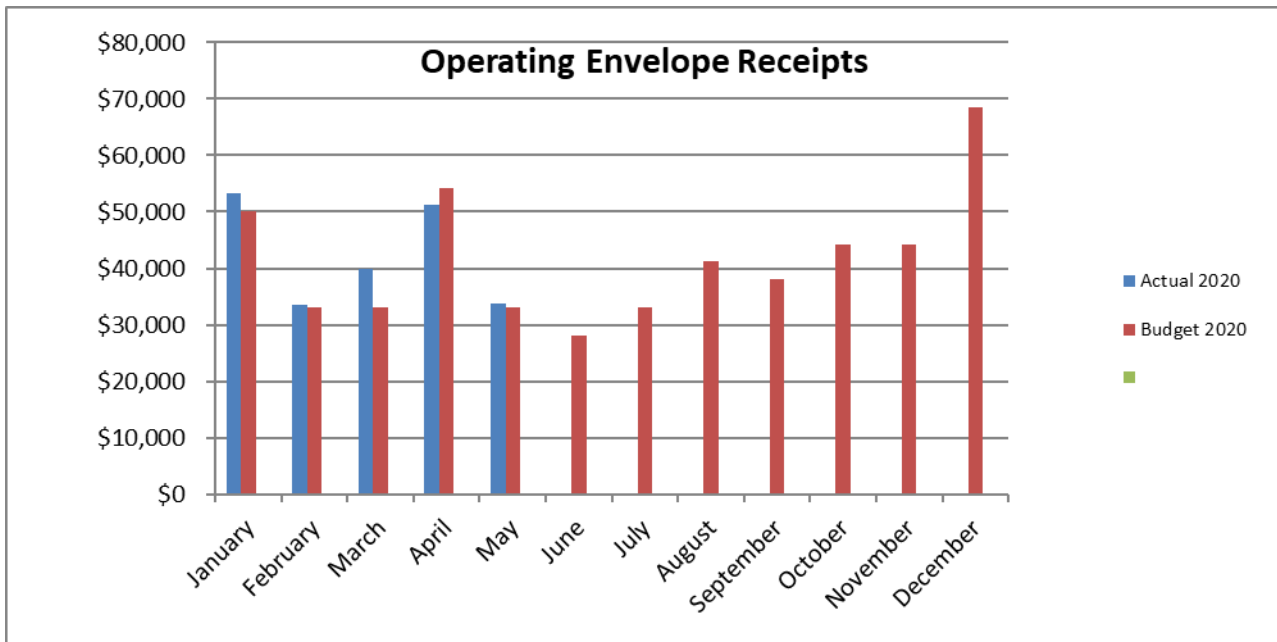
## General Fund

The 2020 General Fund Budget of \$671,955 was approved by the Congregation at the semi-annual meeting on February 2, 2020. This represents a 11.9% increase from 2019 actual receipts and a 4.4% increase from the 2019 budgeted amounts. The 2020 budget will be funded by both the General and Seeds to Branches Funds during the year. The 2020 budget includes \$501,300 from Operating Envelopes /EFT and \$141,924 from the Seeds to Branches Fund.
